Section A: Research Methods

www.PapaCambridge.com Questionnaires and structured interviews are quantitative research methods much loved positivists. Postal questionnaires containing 'closed' questions (that is questions requiring a or 'no' answer) are ideal for scientific purposes. They are quick and cheap. The sample can controlled to achieve representation, the data is easily collated, and the findings can be analysed statistically and generalised. There is no ambiguity in the data and therefore it is more straightforward to draw conclusions.

Another group known as interpretive sociologists are critical about the value of using questionnaires and structured interviews. They prefer qualitative research methods, such as unstructured interviews and participant observation studies. Both positivists and interpretive sociologists accuse each other of producing research data that is affected by bias and distortion. Positivists also claim that qualitative research lacks reliability, while interpretive sociologists respond by saving that quantitative research lacks validity.
